Prohibits carrying firearms into hospitals and mental health facilities

Comments: amends the firearm provision to prohibit the carrying of any firearm into a hospital as well as any mental health facility or community health center, regardless of whether the person is otherwise prohibited from possessing the firearm

Provides for visitation policies at certain healthcare facilities and requires that such policies allow for in-person visitation

Repeals licensure by endorsement for registered nurses

Provides relative to nursing education

Comments: -permits a student to register as an LPN if he completes two years of clinical courses in a registered nursing program -permits a nursing student who completes a course in the fundamentals of nursing offered by a practical or registered nursing program shall not be required to complete a certified nursing training or competency evaluation program and may register as a certified nurse aide (CNA) in this state

Provides relative to a recommendation of medical marijuana in employment
